## Police recovers 'abducted' pastor

CALABARZON police has recovered a Protestant pastor allegedly arrested without warrant by members of the Philippine Army late last week.

Pastor Edwin Egar, 45, was "abducted" by members of the Philippine Army around 5 p.m., from a relative's residence in Brgy. Alupay,

Rosario, Batangas, said Pastor Joram Calimutan, coworker in the United Church of Christ in the Philippines (UCCP).

According to Calimutan who talked to Egar's

## Batangas Port dilemma

BATANGAS PORT is confronted with a serious problem in management albeit shipping industry support to make it the primary seaport in the Calabarzon, or Region 4A.

The Philippine Ports Authority (PPA) is now faced with a dilemma on who will manage the Batangas Port Phase II as the expiration of its contract with Asian Terminals Inc. (ATI) draws near.

ATI Batangas Inc., a subsidiary of Manila-based ATI, has been engaged by the PPA to temporarily manage the Batangas Port Phase II and provide cargo-handling services at the international container terminal of the port for one year starting March 25, 2008.

Recently the port authority has issued an indefinite permit to operate to ATI in order not to further hamper commercial operations of the port.

It is also one of the two eligible bidders for the 25-year management and operations contract for Batangas. The other bidder is International Container Terminal Services Inc. (ICTSI).

The PPA is also working on the privatization of Batangas Port. It has received interests from many firms to operate an international cargo terminal at the Southern gateway.

Those interested include the Filipino-Kuwaiti firm KGLI-NM, International Container Terminal Services Inc.—operator of the Manila International Cargo Terminal—and Asian Terminals, which also runs the Mariveles grains terminal.

The PPA is also working out with the Peza and the BOC a list of possible incentives to entice shippers into the region.

Planning for the development of Batangas port started in the 1980s. The port is envisioned to contribute to the economic Various sectors of the shipping industry support the idea to make the Port of Batangas the primary seaport in the southern part of the country.

Representatives of the Bureau of Customs (BOC), Philippine Ports Authority, Philippine Economic Zone Authority (Peza), Association of International Shipping Lines, Asian Terminal Inc. and Peza locators in Calabarzon stressed the importance of developing the port to service the shipping needs in the region.

Calabarzon is the acronym for the Cavite, Laguna, Batangas, Rizal and Quezon.

Development of the Batangas Port should be considered as extremely important for the country's economic development as the port is vital to the transportation of

## P285.8 M road project to interconnect 2 Mindoros

A P285,8 million road construction project will interconnect the sourthern portions of Oriental and Occidental Mindoro.

The Department of Public Works and Highways (DPWH) said it has released the fund for the Mindoro East Coastal Road Nautical Highway (Mecrnh)) which will start right after the bidding set this month.

Mecrnh will pave the way for the interconnection of the two Mindoro provinces, a vital link that is expected to jumpstart their economic recovery.

Dubbed the "food basket" and major tourist destinations in the Southern Tagalog Region.Mimaropa DPWH Director Veniedo O. Reyes said the new fund infusion came from the regular budget of the department.

DPWH Secretary Hermogenes Ebdane has ordered its release to fasttrack the development of the two Mindoro provinces, Mindoro newsman Robert Evora reported.

The P285.8-million **Mecrnh** 

fund is on top of the R174 million earlier released by the DPWH for the concreting of the 23-kilometer Calapan South Road in northern Oriental Mindoro. The total amount now earmarked for the projects in Oriental Mindoro is P459.806 million.

The P459.8-million appropriation is allotted for the concreting of Bulalacao, Oriental Mindoro, and Magsaysay, Occidental Mindoro, MECRNH mountain road, P115.800 million; concreting of the Calapan South Road,

Western Nautical Highway, P96.5 million; rehabilitation, reconstruction, and upgrading of Calapan South Road, Strong Republic Nautical Highway, P74.305 million; concreting of the 23-kilometer Calapan South Road stretch in Naujan, Victoria and Socorro towns, P170 million; and repair of the damaged Calapan-San Teodoro-Puerto Galera Road, P4 million.

Maliit pa ako, naitanim na sa isip ko ang katotohanang ang ating bansa ay isang bansang



Thus, there are preparations of sumptuous foods in the homes of residents, usually for relatives and visitors

coming from other places. There are dances, music,

athletics and other forms of

entertainment. Being a religious activity, if other forms of entertainment will have to be introduced, they ought to be strictly limited only to those that would enhance the spiritual, moral and cultural values of the people. Any activity that is anathema

to law and morality must be altogether eschewed and avoided. Anyway those who go to the Tupada and other gambling activities do not have in mind the patron saints; they are only driven by their itch to gamble, a vicious immoral habit.

By tolerating illegal gambling therefore during a fiesta, public officials are guilty of desecrating the patron saints who they thereby unwittingly convert into patron saints of illegality and immorality.

It is a blatant disrespect for and denunciation of the church and priest who is pitifully reduced to an impotent figurehead incapable of exercising moral influence over his flock.. It also indicates that attendance in regular church services by said officials is a mere uniform of compliance to show semblance of being piously religious although the truth of the matter is what is being imparted to them inside the church are really of no significance to them.

## Mindoreños assured of Mindoro Nickel's continuity

FOUR different groups from Mindoro Island came out in the open and gave or expressed their resolutions of support to Intex Resources and its Mindoro Nickel Project during the visit last January 13 of Intex Resources board chairman Kjell Almskog in Oriental Mindoro.

goods to and from Mindoro and nearby islands. It is also a strategic trading point for all industries in the region.

The port, the representatives said, also plays an important role in the economic, social and tourism development of the country by being linked with interisland ports known as the nautical highway.

Batangas port is the gateway to Southern Luzon, since it is strategically located within the region that has a volume capacity of of 10,000-ton equivalent units (TEU) a month, Asian Terminals pointed out.

The roads leading to the port should be improved, it added. This would improve travel and processing procedures and lower trucking costs.

Meanwhile, the BOC stressed that Calabarzon locators could save as much as 14 percent in cargo-handling service and 40 percent to 60 percent in transport cost, and the processing of customs documents would only take about 30 minutes.

Large parcels of land would also be available for the container freight- station needs of shipping lines. The BOC noted there would be faster turnaround of trucks because there is no truck ban in Batangas.

Overall, the port is expected to boost local and global trade and unlock huge possibilities to support the country's continued economic expansion. Once in full swing, the port would also help lift the Philippine shipping industry out of its rut.

Other industry stakeholders, however, expressed concern. As in any well-planned, well-funded and well-intentioned government project, the Port of Batangas, they noted, has its own share of hitches and obstacles.

Owing to low shipment volumes, the private cargo handler tasked to run the port's

domestic terminal has yet to turn in a healthy profit from its operations 10 years after the company secured a concession to manage the facility's domestic shipments.

The PPA is working on the privatization of the Southern Luzon gateway. It has received interests from many firms to operate an international cargo terminal at the Batangas port.

Those interested include the Filipino-Kuwaiti firm KGLI-NM, International Container Terminal Services Inc.—operator of the Manila International Cargo Terminal—and Asian Terminals, which holds the temporary permit to operate the Batangas port terminal and runs the Mariveles grains terminal.

The PPA is also working out with the Peza and the BOC a list of possible incentives to entice shippers into the region.

Planning for the development of Batangas port started in the 1980s. The port is envisioned to contribute to the economic development of interisland trade and stimulate the regional economic development of the Southern Tagalog, and function as the point of access to Mindoro Island, which supplies agricultural products to the capital region and the Southern Tagalog.

It is also envisioned to serve as the country's second port after the Manila port which suffers from traffic congestion.

Large parcels of land would also be available for the container freight-station needs of shipping lines. The BOC noted there would be faster turnaround of trucks because there is no truck ban in Batangas. Batangas Port is one of the 10 ports being groomed to be at par with world standards by 2010 and is also seen to become one of the major transshipment hubs in Asia.

Marasigan said, Arceta was arrested with Jessa Brillon, house owner, and her 5-year-old daughter. Brillon and the child were released two hours later while Arceta was detained at Camp Vicente Lim.

Supt. Josemarte Paras, Calabarzon regional police public information chief, said an investigation was ongoing.

Arceta's brother Rudy, 49, who immediately went to the camp to verify the arrest, said it was an illegal arrest since the name on the arrest warrant and list of the so-called Southern Tagalog 72 said "Rey Arceta."

"That's not him," he said, insisting that his brother is Leonardo.In a statement,

Marasigan said Arceta is a legitimate organizer of Olalia-KMU.Arceta's eldest son Reynaldo, 31, said that the cases against ST 72 were bogus charges filed against union leaders.

He questioned the arrest warrant as it only bore the name "Rey Arceta," while his father's name is Leonardo.He said the family was worried because Leonardo was suffering from goiter and had difficulty breathing.Arceta is the eighth militant leader arrested for the alleged 2006 ambush of police by suspected rebels in Oriental Mindoro.

Others in the list of ST 72 include Remigio Saladero Jr., chief legal counsel of the KMU, who has been detained since Oct. 23 last year. The 72 face charges of multiple murder and multiple frustrated murder in connection with the ambush.

Arceta was released from Camp Vicente Lim in Laguna at around 5:15 a.m. Tuesday and was taken to the Calapan Provincial Jail in Oriental Mindoro, said his eldest son Reynaldo Arceta.

relatives, several men in civilian clothes and who introduced themselves as members of the Philippine Army, arrested Egar and forced him into a black Crosswind with plate number WDF543.

Several other men were aboard a Honda Civic.

"No arrest warrant was presented," Calimutan said in treating the incident as an abduction.

Officials of the nearby Brgy. Macalamlam, together with Egar's wife and relatives, followed the two vehicles and found the Crosswind in Camp Vicente Lim, Canlubang.

Egar has been working with the Commission on Christian Witness and Service, under UCCP, on human rights and environmental issues in Macalamlam, Batangas, for four years now, according to his co-workers in the UCCP.

He has been listed as one the 72 activists facing murder and frustrated charges for an alleged New People's Army ambush in Occidental Mindoro.

As of 9 p.m. Wednesday, Superintendent Primitivo Tabujara, chief of the regional intelligence, said he was still checking which unit of the police or the military conducted the operations arresting Egar.

As of 10 p.m., Chief Superintendent Rodolfo Magtibay, PNP deputy regional director for the Calabarzon (Cavite, Laguna, Batangas, Rizal and Quezon region), said they were "on the way" to bring Egar back home Wednesday night, as the murder warrant was already quashed.

"It was just a misunderstanding with the Philippine Army (arresting unit)," he said.
