Priest joins call vs ning in Mindoro

A NORWEGIAN company's proposed mining projects will threaten the rice supply in Oriental Mindoro province, warmed a priest who works in Calapan.

The area where Intex Resources plans to operate nickel mines produces 51 percent of the province's rice requirement, according to Father Edwin Gariguez of the Calapan apostolic

If rice paddies are destroyed, it will also affect the food supply for Manila, where some of the rice is sold, the sociologist-priest said at a recent forum in Quezon City.

Calapan vicariate covers Oriental Mindoro, where 83 percent of 708,000 people are Catholics and the rest are mostly other Christians and indigenous people with native beliefs. Occidental Mindoro is the other province on the island of Mindoro.

Intex's mining proposal was among six cases studied by British environmental experts Robert Goodland and Clive Wicks for their book "Philippines: Mining or Food?" launched during the Feb. 4 forum.

The other cases involve approved projects on the central island of Sibuyan, part of Romblon province, and in the southern provinces of Davao Oriental, South Cotabato, Zamboanga del Norte and Zamboanga del Sur, all in Mindanao.

According to the scientists, the nickel mines that Intex hopes to operate by 2011 straddle 9,720 hectares across both Mindoro provinces. The nickel deposits are in areas that come under Mangyan communities' ancestral domain, and the



## A position paper against the scandalous prevalence of illegal gambling in the Municipality of Odiongan

THERE are dances, music. athletics and other forms of entertainment. Being a religious activity, if other forms of entertainment will have to be introduced, they ought to be strictly limited only to those that would enhance the spiritual, moral and cultural values of the people.

Any activity that is anothema to law and morality must be altogether eschewed and avoided. Anyway those who go to the Tupada and other gambling activities do not have in mind the patron saints; they are only driven by their itch to gamble, a vicious immoral habit.

By tolerating illegal gambling therefore during a fiesta, public officials are guilty of desecrating the patron saints who they thereby unwittingly convert into patron saints of illegality and immorality.

It is a blatant disrespect for and denunciation of the church and priest who is pitifully reduced to an impotent figurehead incapable of exercising moral influence over his flock.. It also indicates that attendance in regular church services by said officials is a mere uniform of compliance to show semblance of being piously religious although the truth of the matter is what is being imparted to them inside the church are really of no significance to them.

Involvement in illegal gambling by public officials unmistakably reflects highly questionable personal moral character that is not a good example to their followers. It is also indicative of picayune intellectuality to distinguish between right and wrong, between good and bad

The plans, decisions and actions of a person reflects the true nature of his moral character. When he is righteous he is free from pangs or qualms of conscience.

If in his behavior he strays outside of the pale of the law and morality his capacity to determine between right and wrong, between good and bad, becomes the exclusive property of the moron, at most questionable before the bar of public scrutiny.

It is really amusing, in fact preposterous and ridiculous, that public officials who tolerate illegal gambling, although they do not say it, are actually intimidated by the possibility that the issue will interfere with their re-election agenda. The moron is also a coward!

6) Public officials and police being insulted by gambling lords and their subalterns.

Our public officials and police, on account of their very limited comprehensions and / or perverted character, fail to recognize or are insensitive to, the insults being heaped upon them by gambling lords and their minions, the bet takers.

The gambling lords, especially, are treated as special citizens with special privileges not ordinarily enjoyed by others, allowed to rake in hundreds of thousands, nay millions, of pesos in illegal income and who are situated in the upper crust of society in the community.

No less than 80 percent, perhaps many more, of the gambling lords, some of whom are also drug lords, are not native born here in Odiongan. They were born elsewhere although they established residences only in this town where they enjoy extraordinary patronage of officials who are native Odionganons but nevertheless do not care, never mind the insults being heaped upon them. The height of stupidity!

7) Excessive gambling and proliferation of compulsive gamblers are a serious hindrance to the development efforts of a town, province and

Gambling diverts people's attention from productive undertakings. Whereas the people's physical and mental energy may be harnessed towards creating and mass producing utilizable and marketable articles and goods to fill man's needs and the surplus to fuel trade and commerce people's precious time are wantonly wasted away in useless and vicious indulgencies.

It should be remembered that the basic materials for development and progress, notably for industries, are people. Raw materials are only secondary as lack of it cannot be a deterrent to a people who are

determined to attain progress. Raw materials can be obtained elsewhere while a determined people are a rarity. When people are not equipped with the proper decision and the correct attitude the availability of raw materials do not serve any useful purpose.

8) Illegal gambling activities unfairly swells pockets of gambling lords while taking away the precious hard earned money of the gullible whose innate weakness of human greed impels them to be victims of exploitation.

Hope springs eternal. This truism is what facilitates the exploitation of the gullible who, motivated by natural human greed, are tempted to bet in gambling in the hope of winning, even if their chance is verv slim.

When a bettor wins, which is very rarely, the satisfaction of winning tempts him to bet some more; if he losses, just the same he gambles the more in the hope that his losses will be recovered. In the long run the person losses plenty but, rather than learn the lesson, the itch to gamble persists, all because of human

9) <u>Illegal gambling is source</u> of illegal income in the form of

All activities that provide derivable income such as business, exercise of profession or giving services are subject to regulation through licensing on which fees and dues are imposed and collected.

In the case of illegal gambling the regulation consists merely of tolerance where there is no written permit but simply by verbal go-signal of the public official which means there is an assurance for the illegal activity to be held without being bothered by the authorities as if it were legal.

Since the return of investment in illegal gambling is usually enormous, very much more than that derived from legal business, it is really inconceivable that the official giving protection will not also benefit from the undertaking. Thus, in illegal gambling it is not mere suspicion that public officials and the police are receiving bribe money; it is a foregone conclusion!

10) <u>Illegal gambling is always</u> attended by cheating and all forms of dishonesty often times resulting in serious disagreements and sometimes violence.

In illegal gambling no official in authority is supervising the activity to impose discipline and the observance of sportsmanship and fair play. Among the more frequent

participants are compulsive gamblers who take to the activity not already as a sport and will not hesitate to apply dishonest methodologies to be in an advantageous position of greater winning chances.

It can be fixing a sultada in tupada or making it appear that a bettor placed his bet in a losing cock although he really intended to and placed his bet in the winning cock. Sometimes it can be in the payment of bets where the amount paid is less than the actual amount placed as bet.

When the aggrieved party insists on his right, the dispute can possibly escalate and result in violent quarrels.

In Barangay Pato-o there was an incident where one cock owner drew his knife and chased the sultador of the opponent cock. A relative of the person being chased drew a homemade gun and aimed it on the person with the knife. At that precise moment a cousin of the knife wielder was already at the back of the gun wielder, also ready to drew his knife. Luckily the chase stopped upon intercession of the proverbial cooler heads and further trouble was averted.

In sitio Boliganay, Barangay Panique during one fiesta celebration, there was an incident where a tupada participant chased another and stabbed him. Luckily, the victim was rushed to the hospital and survived.

A case was filed in the RTC where it was still pending after

three years when another case of stabbing happened in the same place, also during a tupada in connection with the fiesta of Sitio Boliganay.

11) Incidence of illegal gambling encourages thievery other immoral indulgencies.

Where there is illegal gambling many people, some still very young, become involved in the vicious activity. The result is that, in their need for money to bet, especially if they sustain losses, they resort to thievery and many people lose livestock, like chickens and pigs, and other property.

About ten years ago we know of a young woman who was a bet collector in ending. She became inured to fast easy money and developed a propensity to be spendthrift. However, there were times when the takes in ending where not so good as to cope up satisfactorily with her expenses.

She was often far away from husband and children and eventually ended up as a quereda of a comparatively rich man. Very much later on, we were informed that she was already a full fledged prostitute.

To our public officials and police: Pray, tell us what benefit is there in illegal gambling that you have to sacrifice legality and morality and tolerating it?

proposed mining sites encroach on Mag-asawang Tubig Watershed, which feeds 40,000 hectares of rice land.

Father Gariguez has worked among indigenous Mangyan-Alangan people on the island. "We have been opposing mining for a decade, because we feel mining not only threatens food security of Mindoro, but environmental security as well," he said.

Bishop Warlito Cajandig, who heads Calapan vicariate, in a Jan. 19 Public Statement on the Issue of Mining, described the proposed project as "irresponsible activity, more so if it will be conducted in a critical watershed."

The bishop quoted Heherson Alvarez, former Department of Environment and Natural Resources (DENR) secretary, who wrote that no measures could prevent "real destruction of this watershed if mining will push through." Alvarez had canceled an agreement for mining exploration at the site, but the Philippine president's office revoked his 2001 order in 2005.

Goodland, a former World Bank adviser, told 90 guests at the launch, held at the University of the Philippines, that any responsible government should always choose food security over mining.

Citing DENR reports, Wicks pointed out that 90 percent of 190 national watersheds are underforested — 135 of them having less than 30 percent
